
Hello everyone, sorry for the late arrival of this months newsletter, I have been un-well.

From the Commitee:

The committee has some mixed news to share with the community this month.

First we are pleased to announce that work has started on repairing the front walls, this involves supporting the structure of the wall to try to prolong the life of the existing wall, then as per NCAT orders covering the wall in Hardies Matrix panels, having them painted then applying the estates name, logo and address, this will cost approximately 55K.

The next issue the community needs to address are the quotes and costs to repair the commercial area pool (known as the Strata pool). For the past 12 months the committee has been seeking suitable quotes to address this issue, we now have 3 quotes and the committee will call a special general meeting for the community to discuss and approve the preferred quote at a cost of approximately 80K. At this special meeting we will also ask the community to approve first stage of the changes to the Community Management Statement (CMS). These are important changes for the benefit of the community and to ensure our CMS complies with NSW legislation.


As some residents may have noticed, the community Facebook page has been unfortunately shut down. This is an action the committee recommended due to recent actions taken by a lot owner in regards to a threat of legal action being taken.

This is an extremely disturbing situation. This means the community at this stage has no informal means of a community based information service that reaches many in a quick manner. The community will be advised of this disturbing issue, as it may have serious consequences for the whole community.

The committee is planning a Rosedale Park style meeting for residents, to discuss and inform the community of this potential legal issue, this meeting will be held in the next few weeks. Notice will be provided on the below mentioned Facebook page and your neighbourhood representative will be able to provide details.

The committee has created a Pacific Lakes Estate Official group, this will strictly only be available for residents and lot owners and proof of your residence will be required. This page is to provide official information to the community, not a service for residents to post or comment.

EMBERS

Last month I stated I would write about embers this month. Back in 2003, Canberra was hit by a huge bushfire resulting in the destruction of more than 400 houses. The CSIRO carried out a survey of the fire and reported that the actual bushfire did not destroy one single house. All of the destruction was the result of ember attack.

In 2018, the south coast town of Tathra was hit by a bushfire, resulting in the destruction of about 70 houses. A university in Queensland carried out a survey. I heard a radio interview with one of the professors and he stated that not one house prepared against ember attack suffered any serious damage. So. What is an ember? As we all know, hot air rises. When a bushfire is burning through a forest canopy, there is so much heat that air can rise up at gale, sometimes hurricane, speed. As a result, leaves, small sticks and pieces of bark that are on fire can be hurled hundreds of metres into the air. They are embers. With gale force winds, those embers can travel huge distances before falling to ground. In 1994, embers from a bushfire near Spencer flew diagonally across the Hawkesbury River for 7km before setting Mougamarra Nature Reserve on fire. Once leaving the fire they stop flaming, but continue to smoulder. With high temperatures and low humidity they will continue to smoulder for a longer period of time, more than in normal conditions.

When embers land they become stationary and are fanned by hot, strong and dry winds they will then burst into flame. If such an ember lands in a roof gutter full of dead leaves or in a back yard full of rubbish or long grass there is every chance that the house will catch on fire. In the Canberra fire, with 50 degrees and no humidity, embers were setting fire to wooden fences and garden mulch.

On a day of 40 degrees and gale force winds, if a severe fire is burning to the west of the highway, then embers will have no trouble reaching our estate, so the best way to protect our estate from bushfires is to keep roof gutters clean and yards tidy.

Facility Manager's Report

COMMUNITY CENTRE DECKING and Retaining Wall works were Signed Off for Engineering Compliance this month and all areas are now open for public use.

COMMUNITY CENTRE POOL Revised Tenders have been received from local expert pool builders to conform with the NCAT Orders. The Quotes have been submitted to the Committee for approval and then contracts can be signed and construction can commence.

FRONT WALL works have commenced with the steel stitching of the existing wall cracks. Work can now continue with the Matrix Panelling installation, and then followed by the painting and new signage.

MAIN GATE ACCESS CONTROL, ALARM SYSTEMS and CCTV. A full upgrade Tender has been released with proposals from local Security experts under review. Unfortunately intermittent locking and communication problems may still be experienced until the upgrade installation is completed. No new programmable intercom numbers are available at this time.

BY LAW INSPECTIONS continue on a weekly basis and focus on Bins, Car Parking and General Appearance of your Lot.

ABANDONED VEHICLES Only one vehicle still remains and that recovery process has now be handed over as a Council matter.

ARBORIST has now completed all the storm damage and loose tree cleanup within the Estate following the early year storms. They will now focus on some of the perimeter trees and bushland particularly down behind Woodbridge Cr.

RISK ASSESSMENT AND SAFETY REPORT Tender Documents for an upgraded inspection report throughout the entire Estate have been released and should commence in the near future.
